### JOB PURPOSE

The Capital Markets and Wholesale sector is the driving force behind the UK's international financial services success. Post-Brexit, policy makers and regulatory authorities are now looking to develop and enhance the UK's regulatory regime underpinning capital markets and wholesale banking to build a framework suitable for a UK outside the EU's single rulebook.

This is a newly created role as part of UK Finance's expansion and investment in capital markets and wholesale policy. The overarching objective for the post holder will be to establish UK Finance as a credible interlocuter in public policy matters impacting and related to UK primary markets.

The post holder will also be a senior leader within UK Finance and as such be part of the senior leadership team.



### **DUTIES & RESPONSIBILTIES**

- Lead and design a new work programme and strategy in UK primary markets policy that matches the interests and objectives of UK Finance members.
- Build, support and secretariat a lean committee / working group structure around such a strategy some of these committees may be in place upon arrival.
- Identify the key components of UK primary markets, the regulation underpinning them and our corresponding positions this will include, but is not limited to, matters relating to capital raising both debt and equity, IPOs, listings, bonds, the primary market aspects of MiFIR and MAR, retail access to public markets, the prospectus regime and any follow up initiatives from Lord Hill's review of UK primary markets.
- Oversee the primary markets leg of our contribution to the UK's market reform programme – this will include engaging parliamentarians, policy makers and regulatory authorities on the implementation of HM Treasury's primary market reforms.
- Horizon scanning map out and consider the longer-term strategic issues and opportunities facing UK primary markets to support thought leadership and other leading strategic initiatives. The exam question of the day will not always be clear or obvious and so engaging with firms and market specialists to determine a collective pro-active agenda and priorities for international capital markets will be key.
- Undertake strategic advocacy with key stakeholders in collaboration with colleagues in our Corporate Affairs team.
- Generate collateral that simplifies and explains primary markets to non-finance stakeholders. Work with UK Finance colleagues to turn technical markets policy into coherent messaging as part of a wider advocacy strategy.
- Build relationships with (a) our members operating in this space and (b) officials leading or engaged on primary markets policy at HMT, FCA and the Bank of England and other appropriate stakeholders and other trade associations.
- Identify and determine commercial opportunities on primary market topics e.g. webinars, training, conferences, the utilisation of UK primary market data.

### **DUTIES & RESPONSIBILTIES Cont.**

- Manage and lead a direct report (this may involve a dual reporting line) within primary markets through:
  - o acting as a coach and sponsor;
  - contributing to the delivery of team and personal objectives in an inclusive and collaborative way; and
  - o committing to the continuous improvement of UK Finance and its work through professionalism, agility and responsiveness.
- Support, alongside current UK Finance colleagues, senior engagement and relationship management of the UK Finance Corporate Finance Committee – Corporate Finance as a committee and subject matter will set within the primary markets division.
- Be a credible and senior ambassador for UK Finance in the primary markets space.
- Support the Managing Director for Capital Markets and Wholesale in the delivery of a new strategy for markets policy at UK Finance and the delivery of the Capital Markets and Wholesale Product and Service Board.
- As part of the senior leadership team at UK Finance contribute to the development and evolution of UK Finance's strategy.
- Leading and supporting on other activities across UK Finance e.g. briefing CEO and Chair (and others as appropriate) on technical matters, supporting CEO and Chair on meetings relating to matters noted in this job description; contributing to the internal risk register; being the capital markets and wholesale representative on key internal (e.g. operational committee) and external committees (e.g. with other trade associations or representative bodies).
- Co-secretariat the Capital Markets and Wholesale Product and Service Board with the Director, Secondary Markets.
- Operate in a flexible and cross-cutting manner our day-to-day tasks may change with new policy developments and objectives and priorities may also change.
- Facilitate an environment for members and non-members to safely collaborate with a view to creating collective, sustainable and innovative solutions.
- Work closely with the MD for Capital Markets and Wholesale and MD for Corporate Affairs to represent the interests of CMW members to external stakeholders, including Government Departments and regulators.
- Help to prepare industry positions capable of being delivered through interviews, press articles, speeches, and conference presentations, ensuring that complex messages and initiatives are conveyed effectively.
- Support MD to manage risks within CMW through the UK Finance Risk Management Framework.



# SKILLS & COMPETENCIES

- Demonstrate an expert understanding of:
  - UK and international primary markets previous coverage of debt and equity raising, listings, bonds, prospectus regulation is desirable. Either through experience in a bank, law firm, consultancy, regulator or other trade association.
  - Key political, legislative and regulatory issues as they pertain to capital markets policies, in particular the primary markets agenda.
  - The international and inter-linked nature of capital and wholesale markets in particular the impact on UK Finance members from the UK's EU-Exit and wider global market fragmentation.
- An understanding of the variety of challenges and opportunities impacting the future of UK capital markets.
- An ability to generate an agenda / suite of challenges and opportunities that is supported by the industry.
- Proven problem solver; uses objective analysis and a range of information from a variety of sources to inform sound and sustainable decisions.
- Ability to influence at a strategic level through appropriate personal impact. Use a
  wide range of different influencing styles effectively based on an assessment of the
  other party/the audience.
- Ability to navigate different views and drive consensus amongst a variety of organisations.
- Established relationships with regulatory authorities, policy makers and industry participants would be a plus.
- Experience of managing or overseeing the running of expert committees and generating credible output.
- Strong communicator, capable of acting as a subject matter expert and credibly representing UK Finance externally.
- Strong organisational, project management and delivery skills.
- Excellent interpersonal skills.
- Ability to think strategically and to work independently and collaboratively.
- Adaptable and able to quickly pick up new issues.
- Excellent written and verbal communication skills vis a vis senior industry and publicsector representatives.
- A high level of self-awareness, emotional intelligence and aptitude for conflict resolution.
